BRIEF PROJECT SUMMARY: (include a detailed description of activity as an attachment)

Clontz Park is located off of North Church Street on the northern banks of the Pagan River. The Town of Smithfield requests funding from the Recreational Fishing and Advisory Board (RFAB) of the Virginia Marine Resources Commission (VMRC) for the construction of a publically accessible, double boat ramp for its saltwater fishing residents and visitors. Smithfield Foods has agreed to donate the park property to the Town for the purpose of constructing the boat ramp. The Town specifically requests funding to cover the cost for the design and construction of a double boat ramp, access driveway and parking. The park currently has accessible fishing pier, gazebo, riverfront boardwalk, picnic tables and expansive lawn area open to the public, and is maintained by the town under a License Agreement with Smithfield Foods.

EXPECTED BENEFITS: (Describe how your project directly benefits the average Virginia recreational angler)

The Clontz Park boat ramp will serve as the Town's first publicly accessible access to the Pagan River providing greater saltwater recreational fishing opportunities for the Town's residents and visitors. Access to the Pagan River will play an important role in the local economy through additional tourism revenue which will result in additional saltwater fishing licenses purchased annually. The addition of the boat ramp will enhance the use of the existing fishing pier and adjacent park facilities.

DETAILED DESCRIPTION OF ACTIVITY

Currently there is a lack of available public water motorized boat access in the Town of Smithfield. The Town of Smithfield and Smithfield Foods, Inc. have agreed to pursue development of a boating access facility on the Pagan River. Smithfield Foods owns the property known as Clontz Park and the Town currently operates and maintains the park. **Clontz Park** is located off of North Church Street on the northern banks of the Pagan River. This quiet little hideaway park boasts a premier view of the Pagan River. The site includes a gazebo, boardwalk, picnic tables, fishing pier and expansive lawn. The park is named after noted artist, Robert S. Clontz, a longtime resident of Smithfield.

Currently the population of Isle of Wight County and the Town of Smithfield are 36,007 and 8,220 respectively. Out of this population there are currently 1,647 saltwater fishing license holders. (Complete license holder information for FY 15 are included below) It is anticipated the primary users of this boat ramp will be local to these areas, however, due to the limited facilities in Surry County (304 license holders), we anticipate license holders from this adjacent area to use the boat ramp as well.

Jones Creek currently serves as an overflow for the existing boat ramp in Newport News (5,746 license holders) and anglers from surrounding areas such as Suffolk (2,419 license holders) and North Carolina will travel there for access to fish the James River. However, the extensive mud flat on Jones Creek between the existing public boat launch and the Battery Park/Rescue Bridge continues to be filled with sediment. There are no plans for any entities to perform dredging of this noted problem area in the foreseeable future. The Pagan River on the other hand provides unhindered access to deep water which is becoming a scarcity in the area. Currently within the town limits there is only one small shoal (Bob Shoal) and the Pagan River channel remains on the Army Corps of Engineers maintenance list all the way into the Smithfield Foods Corporate Headquarters on Commerce Street. There is deep water from there to Clontz Park, where there is an established No Wake Zone for enhancement of safety. Thus a Clontz Park boat ramp will provide a better, well utilized long term alternative for boaters than the singular dependence on Jones Creek.

Smithfield Foods has agreed to donate the park property to the Town for the purpose of enhancing the existing fishing opportunities on the Pagan River and waterways beyond by adding a dual access boat ramp and adequate parking. This project will consist of engineering design and construction of the following components:

- Double access boat ramp
- Access Driveway from North Church Street
- Parking for 28 vehicles/boat trailers
- Site lighting and landscaping


