

# BLACK SEA BASS INDIVIDUAL TRANSFERABLE SHARES

## APPLICATION FORM

The provisions in VMRC Regulation 4VAC20-950-10 ET SEQ. describe the conditions and limitations for the temporary and permanent transfers of Commercial black sea bass shares of the directed fishery quota. These shares may be transferred to any person who is a licensed registered commercial fisherman or holds a current Seafood Landing License, in addition to a federal Black Sea Bass Moratorium Permit. No person permitted for the directed fishery may hold more than 20 percent of the annual directed fishery quota. Commercial black sea bass shares of the directed fishery quota shall not be transferred in any quantity less than 200 pounds. Any permitted fisherman may transfer shares of his Commercial black sea bass directed fishery quota by completing this application form, having it notarized by a lawful Notary Public and approved by the Virginia Marine Resources Commissioner. All landings of black sea bass in Virginia must be reported as required in 4VAC20-950-49.
