Sunshine Children Fishing Project

This year's project is an expanded version of the annual Sunshine Program Fishing event. Each year, this program becomes larger and more established in the community. The Salvation Army now includes every chapter in the Tidewater area in our event. For the past 25 years, the Sunshine Program has taken over 150 children on 4 head boat trips into the Chesapeake Bay and 200 on piers per year. This year, we are hoping to expand once again by having 2 pier events and 6 boat trips. Supporting the continual evolution of an established charitable fishing program, such as the Sunshine Program, increases the communities' awareness, knowledge and concern about the ecology of the Tidewater area. **We further create Fisher persons –who support the caring use of the resource.**
