### Approval of July 22, 2024, Meeting Minutes:

A Committee Member made a motion to approve the minutes as presented. The motion was seconded. Motion passed 10-0.

### Develop Recommendations for the 2024-2025 Public Oyster Harvest Season:

Andrew Button, Deputy Chief, Shellfish Management, explained the public harvest history. Mr. Button also presented a Draft Season Template of the upcoming 2024-2025 Public Oyster Harvest to the members to gather input from the SMAC members. His comments are a part of the verbatim record.

Member Mason made a motion to extend the James River Clean Cull season through the month of May with the harvest ending at 11 am. with the understanding that each harvester would need to adhere to the Warm Water Harvest restrictions that begin May 1. Member J. C. Hudgins seconded the motion. Motion passed 10-0

Member Kellum made a motion to approve the 2024-2025 Public Oyster Harvest Season as discussed, including extending James River Clean Cull the month of May, for the exception of Piankatank and Great Wicomico harvest areas. Member France seconded. Motion passed 10-0.
