Andrew Button, Deputy Chief, Shellfish Management, explained the oyster restoration overview and the proposed 2026 Oyster Restoration and Replenishment Plan. His comments are a part of the verbatim record.

## SHELLFISH MANAGEMENT ADVISORY COMMITTEE MEETING

Stone would likely be planted in larger, previously approved and permitted areas such as the Mobjack Bay. If shell is not available, a larger portion of the planned replenishment effort could be shifted to stone.

Committee Member Ludford made a motion to accept the 2026 Replenishment plan as presented and discussed. Committee Member Hudgins seconded the motion. Motion passed 9-0-1. Committee Member Kellum abstained.

### **Other Business:**

Committee Member T. Kellum was concerned about oyster buyers buying oysters from harvesters that bring over their limit of oysters to the dock. He suggested that the buyers that purchase over the limit oysters from harvest be held accountable instead of the harvesters. His comments are a part of the verbatim record.

There was also discussion on the current oyster season and possible extensions. A motion was made to request that an Emergency Hearing be held at the February Commission meeting to consider extensions to the public oyster season.

Committee Member Kellum made a motion to request an Emergency Hearing for the upcoming February Commission Meeting for a season extension in the Eastern Shore. A Committee Member seconded the motion. Motion passed 10-0.

A motion was made to adjourn the meeting. A Committee Member seconded the motion. Motion passed 10-0.
